News from Shanghai – [Arie Schreier](#) (2 blogs)

- **China's first step towards their fiscal transformation was the VAT reform that was implemented in Shanghai in 2012.** This initiative was expanded to pilot sectors across the country on August 1st 2012 due to its remarkable success and its bolster the slowing economic growth. On May 1st 2016 the reform was officially implemented throughout all China. The reform program seeks to replace business tax with a value-added tax to avoid duplicated taxation and to lower the tax burden. <http://www.ptl-group.com/blogs/en/how-can-you-benefit-from-the-vat-reform-in-china>
- **Doing business in China is becoming easier and more appealing for foreign companies now that the WFOE set-up process has been simplified.** In early September 2016 a new set of rules were released to ease the burden on the business environment within China by reducing bureaucracy and increasing transparency. The rules specifically support Foreign Invested Enterprises (FIEs) and took effect from October 1st 2016. <http://www.ptl-group.com/blogs/en/wfoe-set-up-in-china>
